\***Al Jenkins**-Representative from Senator Tim Scott's office-would be glad to put in a letter of support for city to assist in grant funding opportunities.

\***Chief Shawn Middleton**-Police-Department would like to develop 10 acres owned by the city to develop youth center that can be used to help children while playing sports, video games, homework; Vickie Gladson from Aiken County Public Schools hopes the police department will be able to secure funding for resource officer at Greendale Elementary. \***Coach David Alexander**-Recreation Department Director-Saturday kicked off football season; good attendance. This Saturday's game schedule: 10am, 11am, & 12pm at New Ellenton Middle School football field. Electricity was completed in press box; uniforms ordered and awaiting arrival; goal posts are good; bathrooms are cleaned twice per week; desperately needing volunteers for concession/gate for games; there was a water main break at football field; need another bleacher for visitor side; may need down markers; area churches may be able to assist with volunteers; deep fryers will need cleaning. \*Jason Morgan-responded that he will work with Curtis to move bleachers tomorrow.

\***Kenny Cook**-City Administrator-Grant submitted on 9/8/22 for sewer plant; asking for total revamp for waste water treatment plant(WWTP) that will cost roughly \$4Million with a city match of \$300,000, if approval of grant is successful; letter from Bill Taylor to RIA may be helpful; liner at WWTP is left will cost well over \$600,000 as lagoon must be drained to install new liner; cost of waste removal is expensive; pump station needs to be replaced; buildings need to be replaced; pipes need to be replaced; won't know until first of the year if city is a recipient of award; engineers working on preliminary plans in the event award is approved in January city will be prepared to begin process for bidding.




