***Deborah Creech-** Updates on Christ Central

In need of volunteers & transportation in the area; Received donated blueprints & plans for future improvement project; Fed over 200 families from surrounding area including Beech Island, Jackson, Williston, Barnwell; Aiken Housing Authority supported summer program; Golden Harvest Foodbank 2nd Wednesday & 3rd Saturday; Senior citizen activities to include bingo, food & other activities; awaiting release of county Fire Marshal's report to move forward with updates; working on grants with Christine Chandler & Lower Savannah Council of Governments; working on development of mini cottages to be built.

***Chad Pope-**EPA Grant geared toward rural areas with \$7 Billion dollars available for funding for Solar for All; State & Municipality program to use funds across a five year period; letter of intent due in August; application due in September; project can be for individual homes and more to improve solar installation and upgrades; Councilwoman Geneva would like to meet with Chad and members of council that are available Monday at 6:30pm.
